## Industry Summary

Cogent Valuation identified publicly traded companies, IPOs, and recent M&A transactions within the Cardiovascular Device industry, which provides a basis for market and transaction pricing that can be used by your firm in estimating market sentiment and its impact on your firm's value. Since June 30, 2013, the median 52-week share price return of the Cardiovascular Device industry has increased by 31.6%. In the last quarter, the median price-to-earnings multiple decreased from 25.6x to 21.8x.

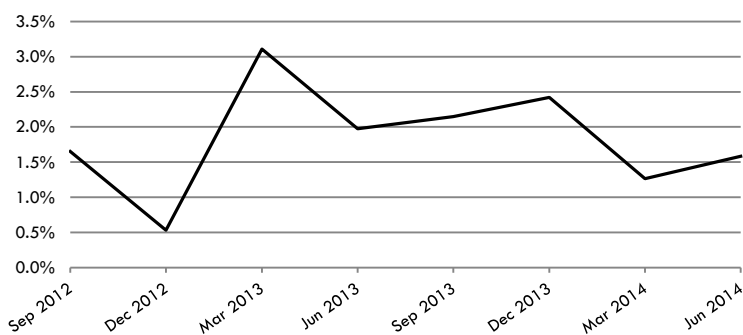

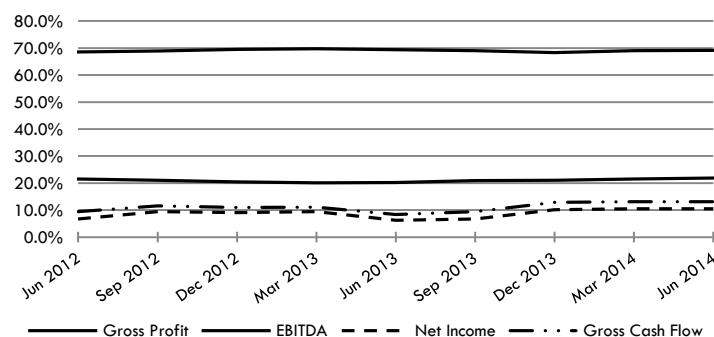

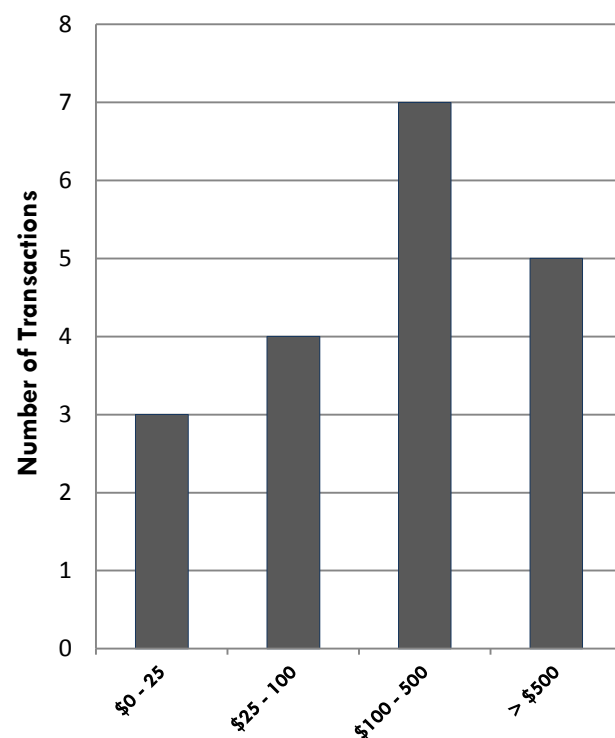
