Industry Summary

Cogent Valuation identified Staffing publicly traded companies, IPOs, and recent M&A transactions within the Staffing industry, which provides a basis for market and transaction pricing that can be used by your firm in estimating market sentiment and its impact on your firm's value. Over the last year since September 30, 2015, the median 52-week share price return of the Staffing industry was -24.1%. Between September 30, 2014 and September 30, 2016, the median EV/EBITDA multiple decreased from 10.6 to 9.7. However, the median price-to-earnings multiple increased from 18.5 to 22.4 over the same period.

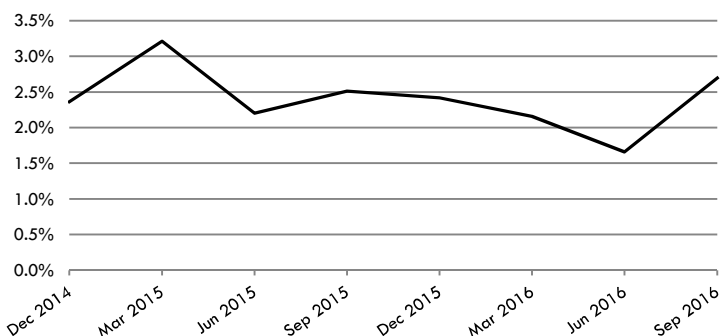

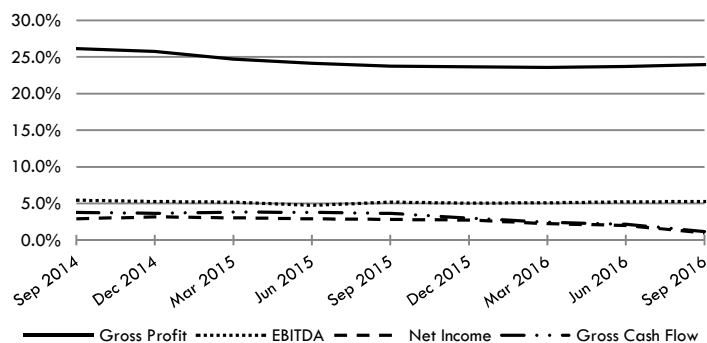

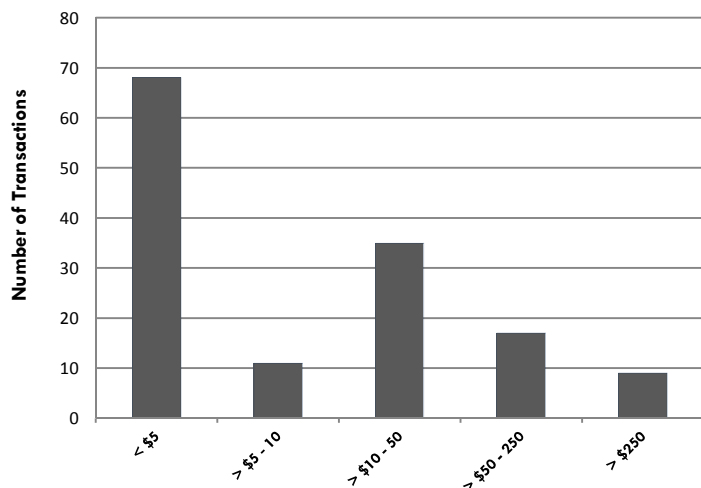

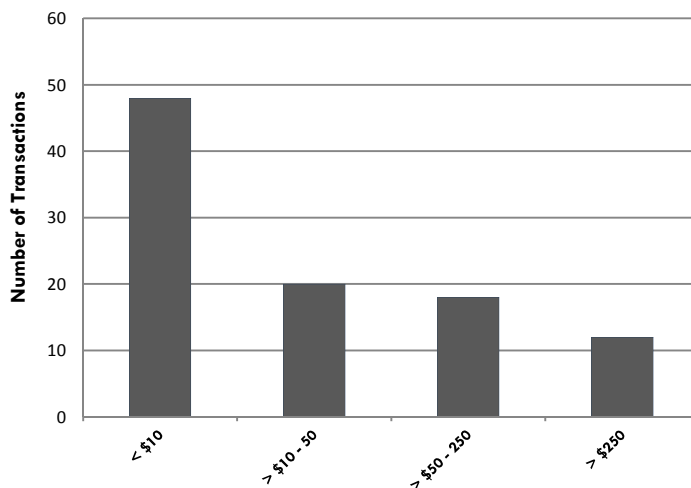
