### INDUSTRY SUMMARY

COGENT VALUATION identified **Consumer Electronics** publicly traded companies, IPOs, and recent M&A transactions within the Consumer Electronics industry, which provides a basis for market and transaction pricing that can be used by your firm in estimating market sentiment and its impact on your firm's value. Over the last year since June 30, 2016, the median 52-week share price return of the Consumer Electronics industry was 5.9%. Between June 30, 2015 and June 30, 2017, the median EV/EBITDA multiple increased from 11.6 to 19.8. Furthermore, the median price-to-earnings multiple increased from 33.1 to 43.6 over the same period.

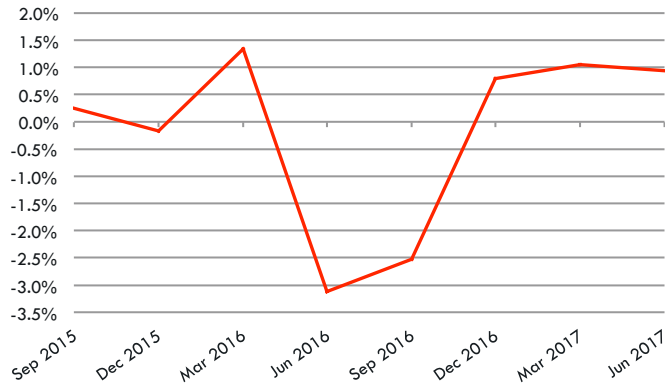

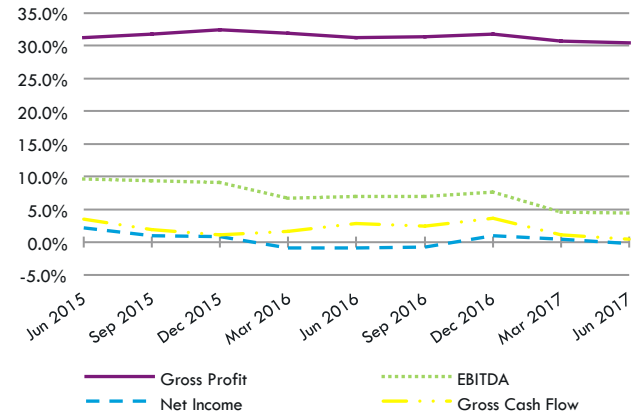
