INDUSTRY SUMMARY

COGENT VALUATION identified **Data Analytics** publicly traded companies, IPOs, and recent M&A transactions within the Data Analytics industry, which provides a basis for market and transaction pricing that can be used by your firm in estimating market sentiment and its impact on your firm's value. Over the last year since June 30, 2016, the median 52-week share price return of the Data Analytics industry was 5.4%. Between June 30, 2015 and June 30, 2017, the median EV/EBITDA multiple decreased from 12.0 to 10.6. Furthermore, the median price-to-earnings multiple decreased from 27.3 to 20.4 over the same period.


