### INDUSTRY SUMMARY

COGENT VALUATION identified **Television Broadcasting** publicly traded companies, IPOs, and recent M&A transactions within the Television Broadcasting industry, which provides a basis for market and transaction pricing that can be used by your firm in estimating market sentiment and its impact on your firm's value. Over the last year since December 31, 2016, the median 52-week share price return of the Television Broadcasting industry was 2.7%. Between December 31, 2015 and December 31, 2017, the median EV/EBITDA multiple decreased from 10.6 to 9.9. Furthermore, the median price-to-earnings multiple decreased from 15.9 to 11.4 over the same period. The median revenue growth and EBITDA margins for the industry for the quarter were 0.7% and 30.0%, respectively.

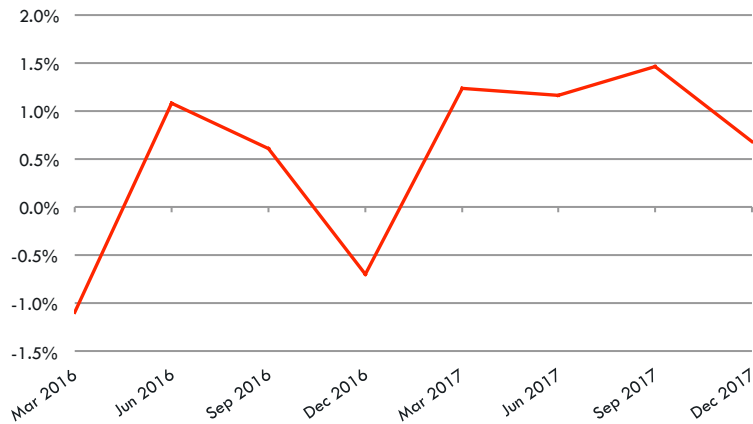

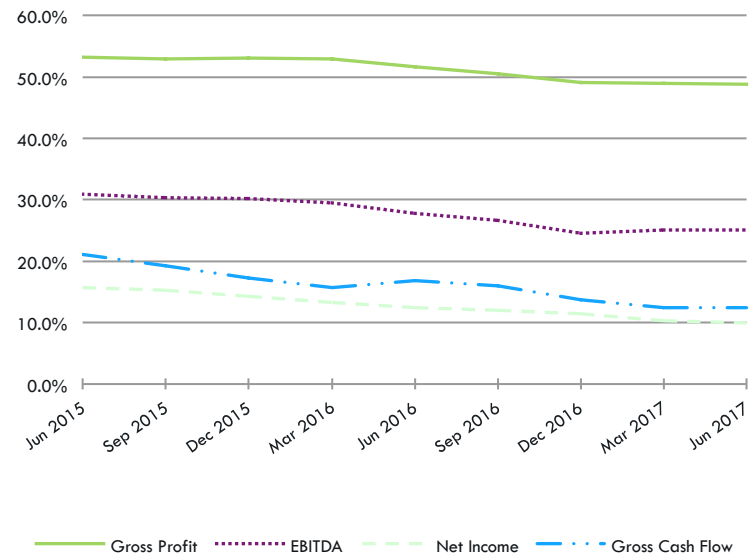

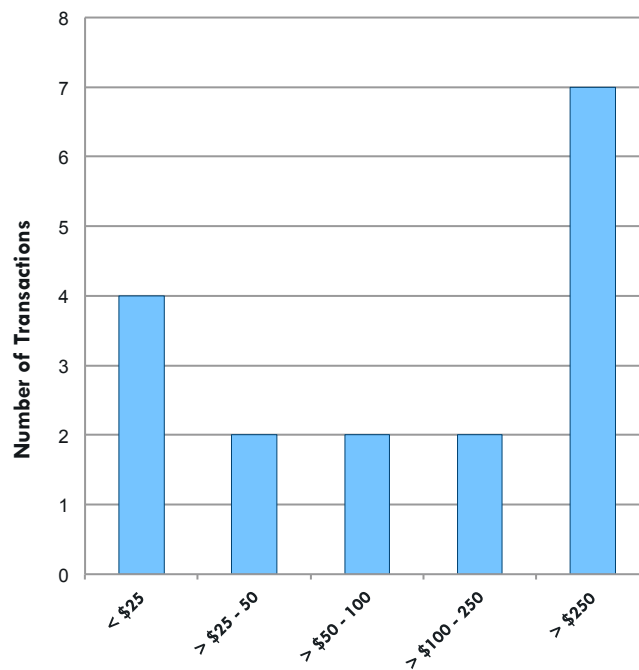
