INDUSTRY SUMMARY

COGENT VALUATION identified **Food Distributors** publicly traded companies, IPOs, and recent M&A transactions within the Food Distributors industry, which provides a basis for market and transaction pricing that can be used by your firm in estimating market sentiment and its impact on your firm's value. Over the last year since March 31, 2017, the median 52-week share price return of the Food Distributors industry was -0.8%. Between March 31, 2016 and March 31, 2018, the median EV/EBITDA multiple decreased from 13.9 to 13.2. Furthermore, the median price-to-earnings multiple decreased from 20.7 to 16.9 over the same period.

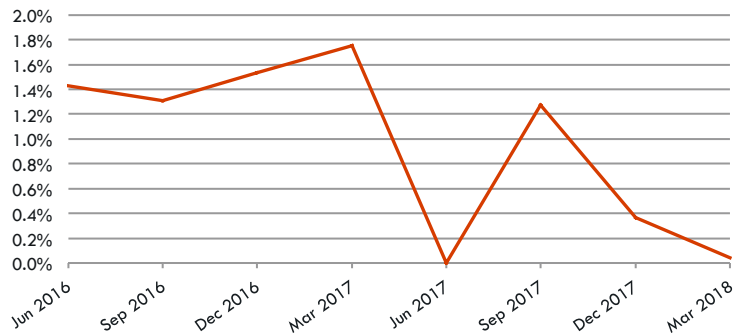

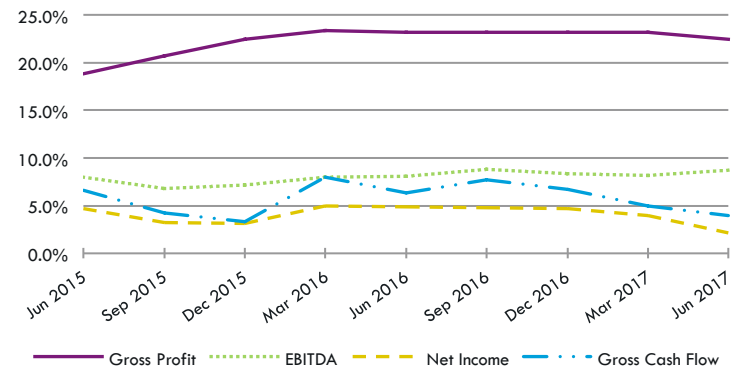

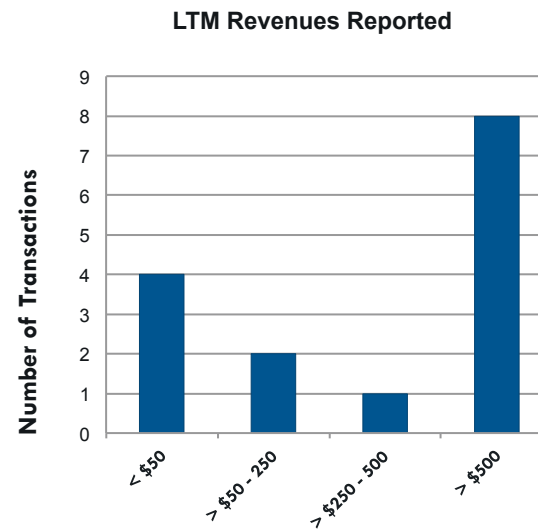
