### INDUSTRY SUMMARY

COGENT VALUATION identified **Investment Advisory** publicly traded companies, IPOs, and recent M&A transactions within the Investment Advisory industry, which provides a basis for market and transaction pricing that can be used by your firm in estimating market sentiment and its impact on your firm's value. Over the last year since June 30, 2017, the median 52-week share price return of the Investment Advisory industry was 0.2%. Between June 30, 2016 and June 30, 2018, the median EV/EBITDA multiple increased from 9.0 to 9.2. However, the median price-to-earnings multiple decreased from 20.0 to 18.1 over the same period. The median revenue growth and EBITDA margins for the industry for the quarter were 2.1% and 29.0%, respectively.

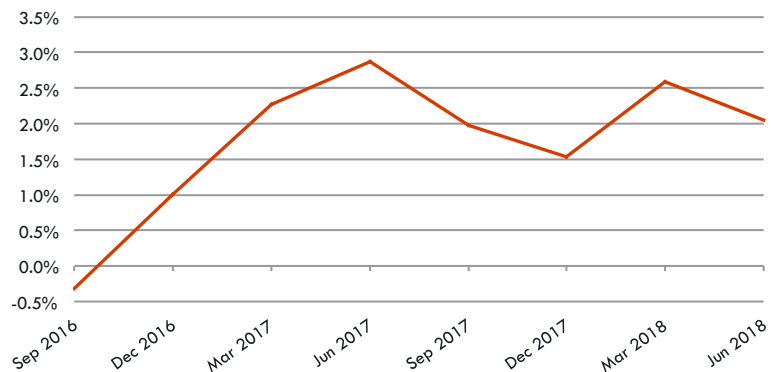

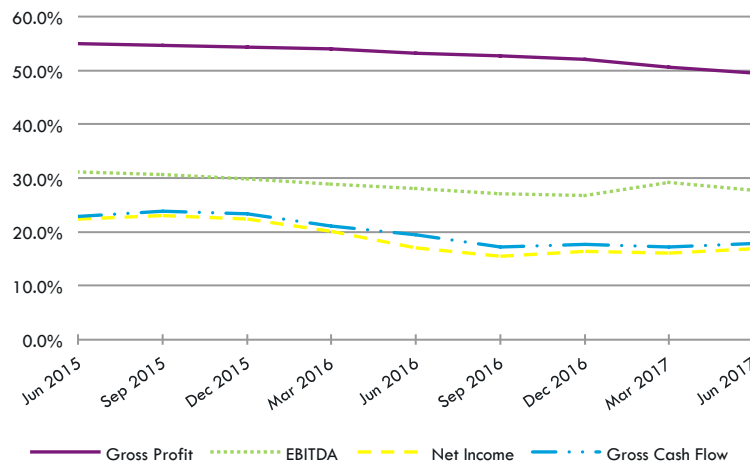

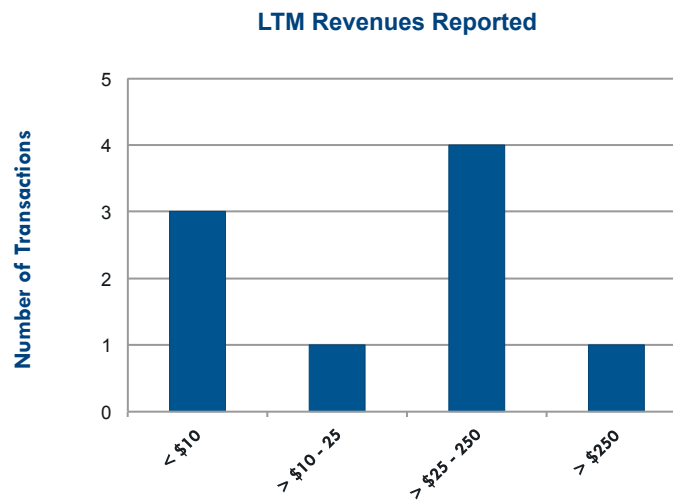
