COGENT VALUATION identified **Oncology Pharmaceutical** publicly traded companies, IPOs, and recent M&A transactions within the Oncology Pharmaceutical industry, which provides a basis for market and transaction pricing that can be used by your firm in estimating market sentiment and its impact on your firm's value. Over the last year since June 30, 2017, the median 52-week share price return of the Oncology Pharmaceutical industry was 18.1%. Between June 30, 2016 and June 30, 2018, the median EV/EBITDA multiple decreased from 13.5 to 12.0. Furthermore, the median price-to-earnings multiple decreased from 17.0 to 14.1 over the same period. The median revenue growth and EBITDA margins for the industry for the quarter were 4.3% and -31.2%, respectively.

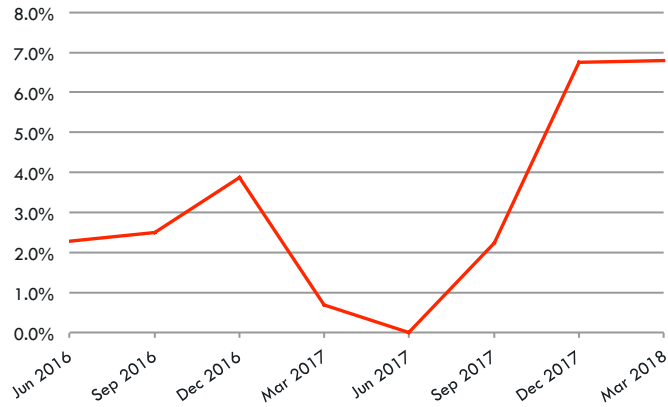

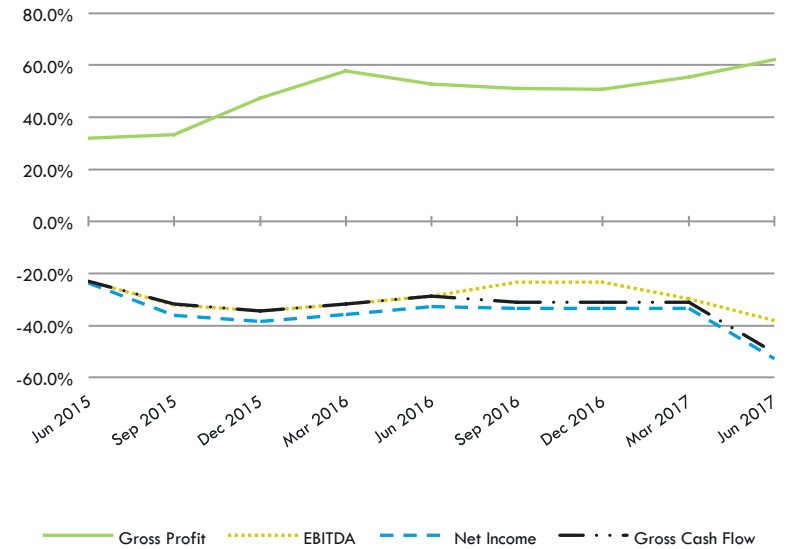

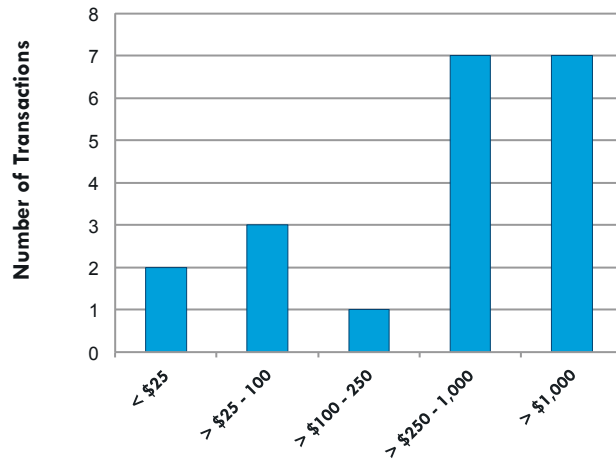

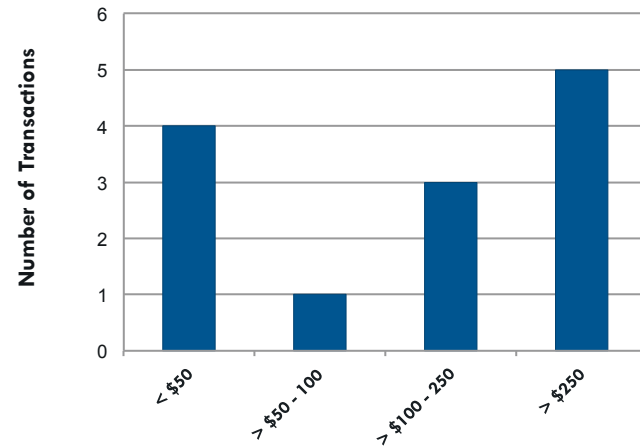
