INDUSTRY SUMMARY

COGENT VALUATION identified **Video Streaming and Content** publicly traded companies, IPOs, and recent M&A transactions within the Video Streaming and Content industry, which provides a basis for market and transaction pricing that can be used by your firm in estimating market sentiment and its impact on your firm's value. Over the last year since June 30, 2018, the median 52-week share price return of the Video Streaming and Content industry was 41.7%. Between June 30, 2017 and June 30, 2019, the median EV/EBITDA multiple decreased from 21.4 to 18.4. The median revenue growth and EBITDA margins for the industry for the quarter were 4.9% and 15.6%, respectively.

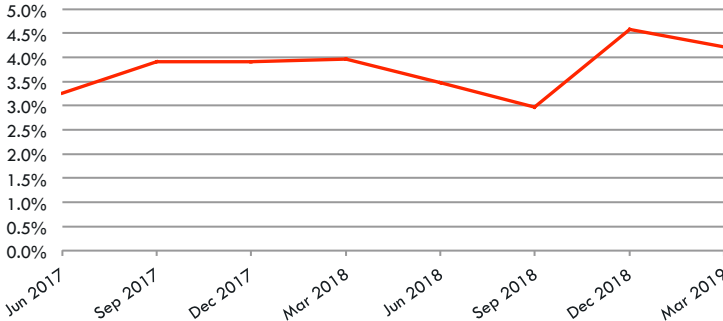

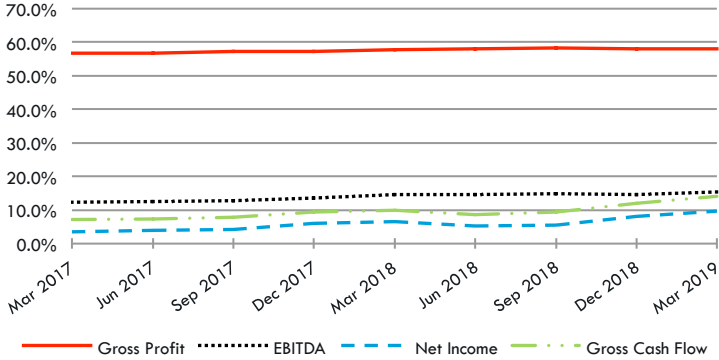

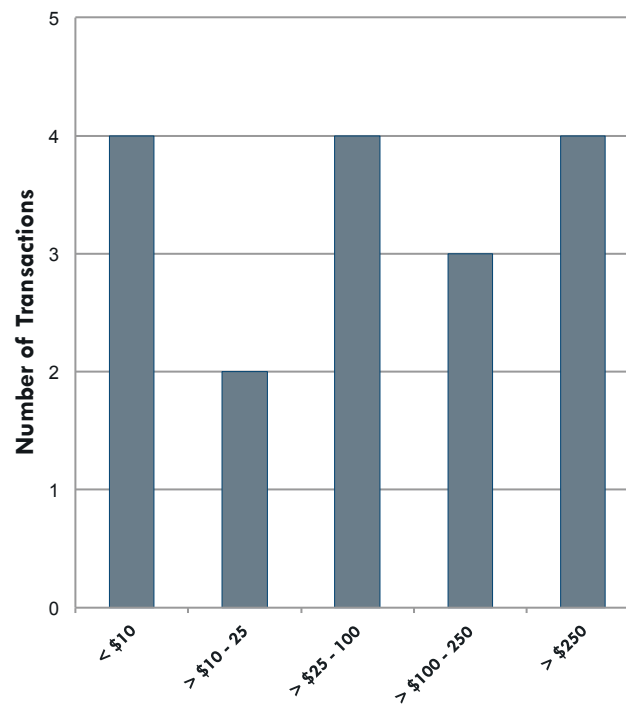
