

# Q2: Quarterly Industry Update

## Specialty Beverages

### INDUSTRY SUMMARY

COGENT VALUATION identified **Specialty Beverages** publicly traded companies, IPOs, and recent M&A transactions within the Specialty Beverages industry, which provides a basis for market and transaction pricing that can be used by your firm in estimating market sentiment and its impact on your firm's value. Over the last year since June 30, 2018, the median 52-week share price return of the Specialty Beverages industry was 14.9%. Between June 30, 2017 and June 30, 2019, the median EV/EBITDA multiple decreased from 22.1 to 19.0. Furthermore, the median price-to-earnings multiple decreased from 47.8 to 34.1 over the same period. The median revenue growth and EBITDA margins for the industry for the quarter were 3.2% and 11.9%, respectively.

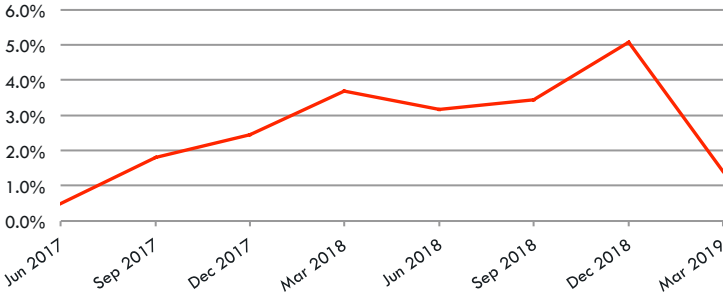

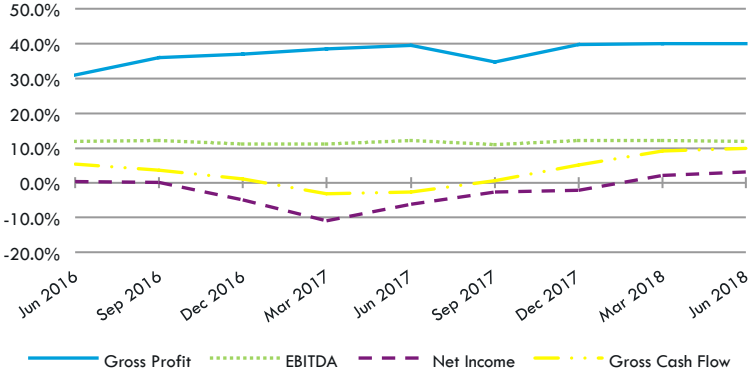

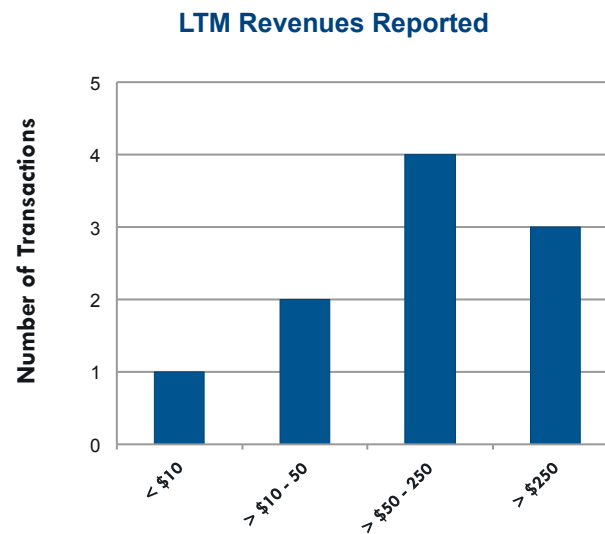
