COGENT VALUATION identified **Inflammation Pharma** publicly traded companies, IPOs, and recent M&A transactions within the Inflammation Pharma industry, which provides a basis for market and transaction pricing that can be used by your firm in estimating market sentiment and its impact on your firm's value. Over the last year since September 30, 2018, the median 52-week share price return of the Inflammation Pharma industry was 5.9%. Between September 30, 2017 and September 30, 2019, the median EV/EBITDA multiple increased from 11.5 to 13.1. Furthermore, the median price-to-earnings multiple increased from 29.2 to 41.0 over the same period. The median revenue growth and EBITDA margins for the industry for the quarter were 0.6% and 0.0%, respectively.






