

# Q3: Quarterly Industry Update

## Neurological Equipment

### INDUSTRY SUMMARY

COGENT VALUATION identified **Neurological Equipment** publicly traded companies, IPOs, and recent M&A transactions within the Neurological Equipment industry, which provides a basis for market and transaction pricing that can be used by your firm in estimating market sentiment and its impact on your firm's value. Over the last year since September 30, 2018, the median 52-week share price return of the Neurological Equipment industry was 28.0%. Between September 30, 2017 and September 30, 2019, the median EV/EBITDA multiple increased from 16.7 to 21.7. Furthermore, the median price-to-earnings multiple increased from 40.7 to 54.4 over the same period. The median revenue growth and EBITDA margins for the industry for the quarter were 2.1% and 21.0%, respectively.

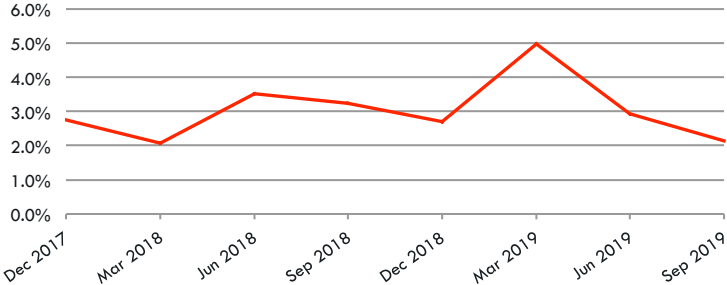

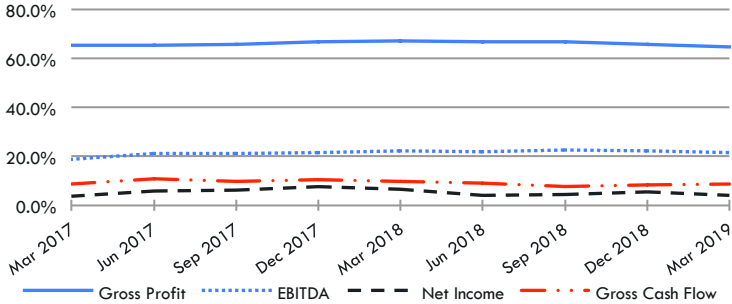

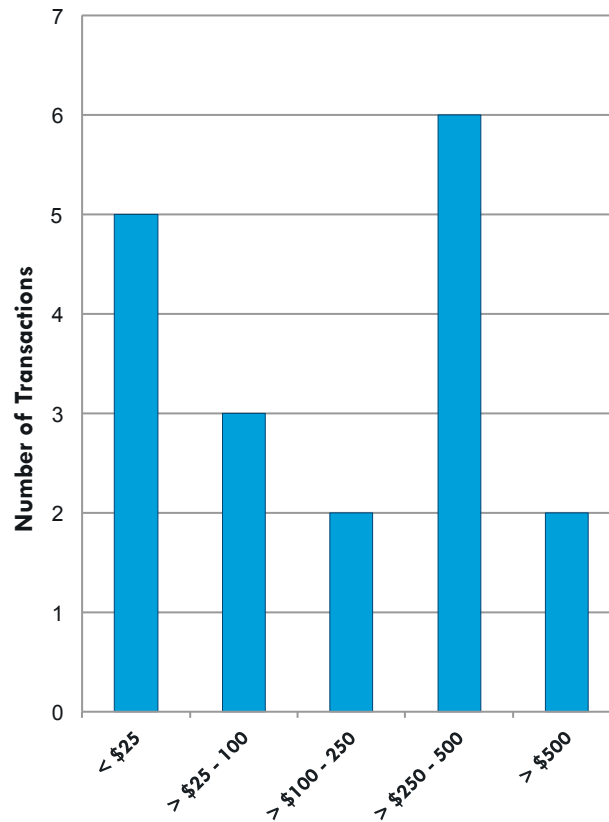
