## Monoclonal Antibodies

### INDUSTRY SUMMARY

COGENT VALUATION identified **Monoclonal Antibodies** publicly traded companies, IPOs, and recent M&A transactions within the Monoclonal Antibodies industry, which provides a basis for market and transaction pricing that can be used by your firm in estimating market sentiment and its impact on your firm's value. Over the last year since December 31, 2018, the median 52-week share price return of the Monoclonal Antibodies industry was 24.4%. Between December 31, 2017 and December 31, 2019, the median EV/Revenue multiple increased from 8.4 to 8.5. This industry is not profitable and all other valuation multiples based on profitability metrics were not meaningful. The median revenue growth and EBITDA margins for the industry for the quarter were -5.5% and -53.2%, respectively.

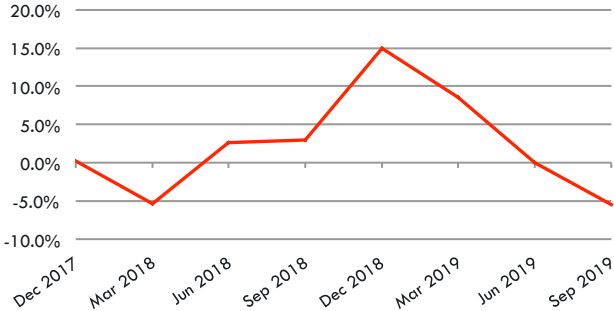

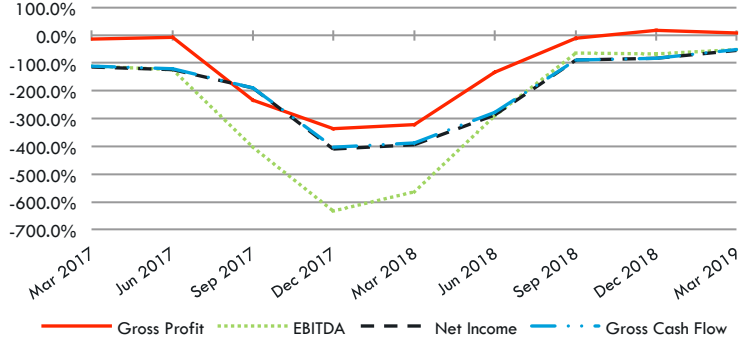
