INDUSTRY SUMMARY

COGENT VALUATION identified **Predictive Analytics** publicly traded companies, IPOs, and recent M&A transactions within the Predictive Analytics industry, which provides a basis for market and transaction pricing that can be used by your firm in estimating market sentiment and its impact on your firm's value. Over the last year since December 31, 2019, the median 52-week share price return of the Predictive Analytics industry was 17.8%. Between December 31, 2019 and December 31, 2020, the median EV/EBITDA multiple increased from 16.0 to 22.6. Furthermore, the median price-to-earnings multiple increased from 27.0 to 44.3 over the same period. The median revenue growth and EBITDA margins for the industry for the quarter were 2.2% and 11.9%, respectively.



Industry Revenue Growth and Profit Margins for the Past Two Years






