INDUSTRY SUMMARY

COGENT VALUATION identified **Food Distributors** publicly traded companies, IPOs, and recent M&A transactions within the Food Distributors industry, which provides a basis for market and transaction pricing that can be used by your firm in estimating market sentiment and its impact on your firm's value. Over the last year since June 30, 2020, 2019, the median 52-week share price return of the Food Distributors industry was -31.0%. Between June 30, 2020 and June 30, 2021, the median EV/EBITDA multiple decreased from 13.6 to 11.4. Furthermore, the median price-to-earnings multiple decreased from 16.8 to 11.6 over the same period.

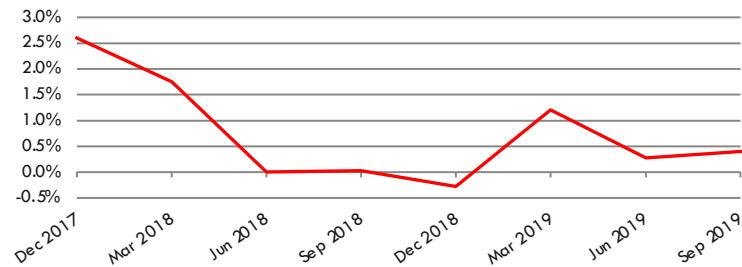

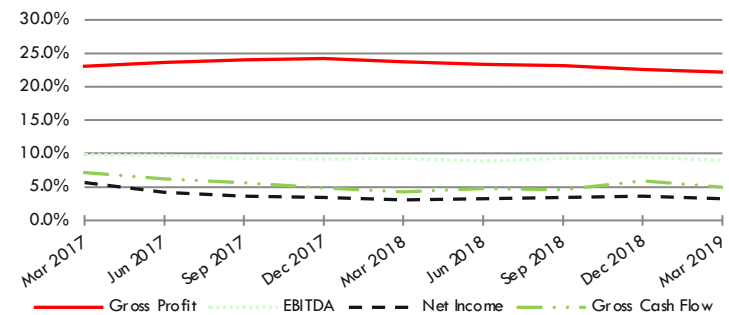

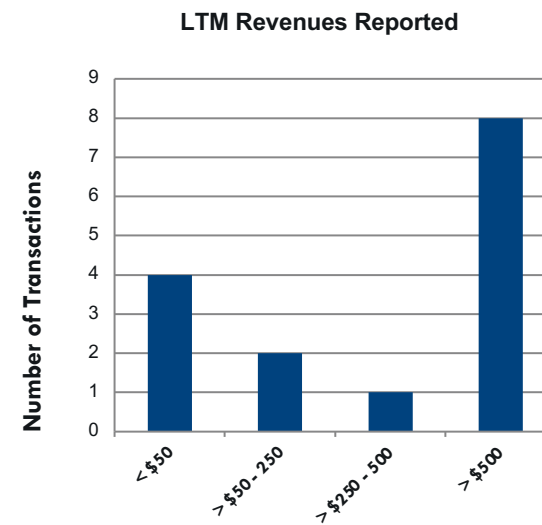
