INDUSTRY SUMMARY

COGENT VALUATION identified **Medical Devices** publicly traded companies, IPOs, and recent M&A transactions within the Medical Devices industry, which provides a basis for market and transaction pricing that can be used by your firm in estimating market sentiment and its impact on your firm's value. Over the last year since March 31, 2019, the median 52-week share price return of the Medical Devices industry was 47.6%. Between March 31, 2019 and March 31, 2020, the median EV/EBITDA multiple increased from 17.1 to 20.0. Furthermore, the median price-to-earnings multiple increased from 42.2 to 53.9 over the same period. The median revenue growth and EBITDA margins for the industry for the quarter were 1.9% and 10.4%, respectively.

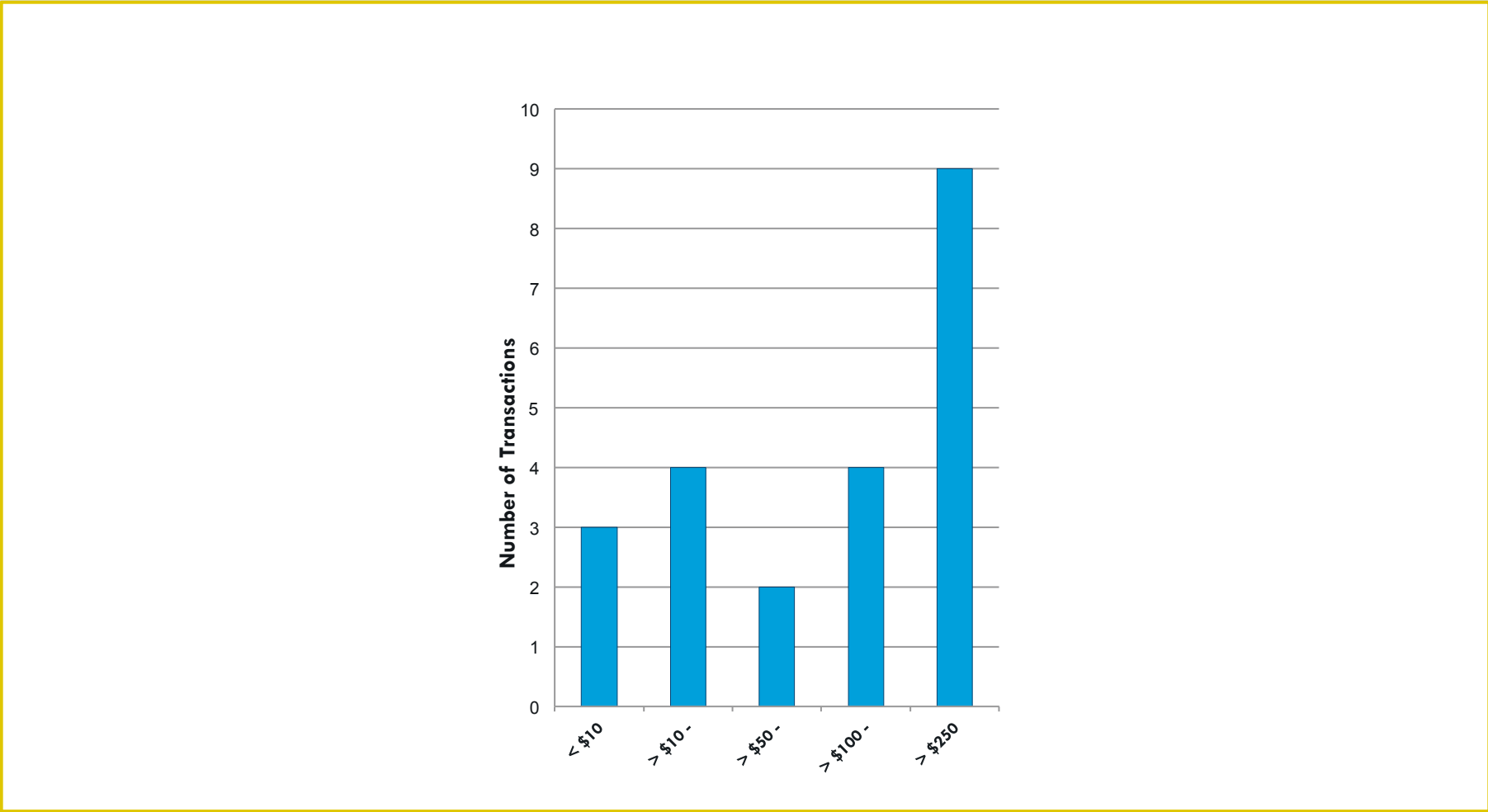
